OFFICE ORDER

As per memo no. 12.00.0000.063.22.005.17-329, date: 20.08.2017, issued by Ministry of Agriculture (MoA), the deputation of Md. Jamal Uddin, Scientific Officer, Bangladesh Sugarcrop Research Institute (BSRI), Ishurdi-6620, Pabna, to study Ph.D at Graduate School of Chinese Academy of Agricultural Sciences (GSCAAS), Beijing, China is granted during the period from 10 September 2017 to 09 September 2020 (36 months) under the following terms and conditions:

- Deputation period including transit will be treated as on duty.
- He will draw his pay and allowances in local currency as per rules. No part of it shall be drawn in foreign currency.
- All the expenses regarding the Ph.D program will be borne by the China Scholarship Council (CSC); there will be no financial involvement of Government of Bangladesh or of the Institute (BSRI)
- He will not be allowed to extend his stay in abroad without the permission of the Government of Bangladesh.
- He should abide by the rules and regulations of the Government of Bangladesh and of the Institute (BSRI).
- He will submit a bond according to the institutional rules and regulations before leave and he will have to abide by all the terms and conditions as per undertaking given by him.
- He will submit a report in prescribed form within 7(seven) days of his joining after returning from abroad.
- He will have to resume his duties after completion of his Ph.D study/deputation.
- A copy of his thesis/dissertation will be submitted to the authority after completion of his Ph.D study.


